
# **Connected Quizzing**


# **Step 1: PURCHASING ACCESS**

**CLASS DAYS/TIMES:** Monday & Wednesday 11:00-12:15 p.m., 1:00-2:15 p.m. & 7:30-8:45p.m. (Students will be assigned a time slot and small group instructor which will be posted in the lobby by the first day of class).

#### **SCOPE**

In this course, you will be required to draft an inter-office memorandum to a senior attorney and a short memorandum in support of a motion to a court. You will prepare several drafts of each memorandum to allow you to refine your writing and editing skills. You will also argue a portion of a client's case in a mock trial court. At the end of the semester, you will feel confident submitting your final memoranda as writing samples to potential employers; you will also feel confident analyzing and advocating a client's cause. The course will have a final exam where you will need to draft an interoffice memo, and a client letter based on materials provided to you. This is very similar to the MPT writing component on the UBE.

#### **COURSE DESCRIPTION**

This course is designed to continue the development of students' legal writing skills as well as building critical reading skills, research skills, and oral advocacy skills. Specifically, students will continue to formulate written rules derived from legal authority, synthesize multiple legal authorities, work on refining IRAC, TRAC, CRAC, or CREAC, organize a written discussion, assess the value of cases as they pertain to a client's legal question, and advocate in a trial court setting.

During the semester students will tackle legal problems starting with client intake at the start of a case, finding legal authority, writing predictive memoranda, and advocating in a trial court setting.

#### **GRADING CRITERIA**

The legal memos, in-class writings, oral presentation, class participation, and the final exam will all contribute to your final grade in this class. This class is designed to train students how to handle client problems, analyze those problems objectively, draft objective and predictive memos, and argue in a trial court. You should be fully prepared for each class and act professionally at all times.

**Penalties for late submission:** <u>We will strictly follow all due dates</u>. We set deadlines for turning in assignments just as courts or partners in law firms do. <u>Grades will be reduced by 10 points on papers that are turned in late on the due date (all papers are due at the beginning of their regularly scheduled class time). Further, your grade will be reduced by an additional 10 points for each subsequent day the paper is late after the initial due date. Grace periods are not granted.</u>

#### ASSIGNMENTS DUE FOR EACH CLASS

Week of January 20<sup>th</sup>: Understanding the legal system and authority. How do we decide which cases or statutes are most important? What law binds Massachusetts trial courts? How do we rank authority by paying attention to key components in a case (relevance, date, place, court)? What are legal citations?

Monday: NO SCHOOL FEDERAL HOLIDY

Wednesday: Introduction to Legal Authority and Basic Legal Citation.

Required Reading: Preparing for Practice Chapters 1-4 and Chapter 14.

Connected quizzes for chapters 3, 4, &14 will open on 1/20 and must be completed by 1/25 at 11:00PM.

Week of January 27<sup>th</sup>: Discussion of closed memo problem. How do I identify the legal issue in a client's case after the intake? What is the format of an interoffice memo? How do I read case law with a view towards using that case to analyze a client's legal problem? How do I properly use the legal writing paradigm known as TRAC?

<u>Monday</u>: Assignment of Closed Memo Problem. *In-Class Assignment 1:* Draft the Issue for the Closed Memo.

Wednesday: Students will get back In Class 1 with instructor's comments.

*In-Class Assignment 2: TRAC/*Synthesis Exercise.

<u>Required Reading</u>: Preparing for Practice Chapters 5-7 <u>Connected quizzes for chapters 6 & 7 will open on 1/26 and must be completed by 1/31</u> at 11:00PM.

**Week of February 3<sup>rd</sup>**: Development of the closed memo problem. Who is my audience? How do I write a legal memorandum to a senior partner describing the state of the law and predicting how a judge will apply the law to a client's case? How do I synthesize the case law to create a rule that can be applied to my client's case?

<u>Monday</u>: Discussion of cases for the closed memo. Students will get back last Wednesdays graded in class assignment to review instructor's comments.

In Class Assignment 3: Headings and Point Headings Exercise

<u>Wednesday</u>: Continue discussion of cases for the closed memo. Students will get back In Class 3 graded assignment.

In Class Assignment 4: Draft the thesis paragraph for the closed memo.

Over the weekend, students should create an outline of the closed memo to discuss on Monday.

Required Reading: Preparing for Practice Chapters 8 & 9.

Connected quizzes for chapters 8 & 9 will open on 2/2 and must be completed by 2/8 at 11:00PM.

Week of February 10<sup>th</sup>: How do I convert an outline of my memo to final memo format? How do I refine the case discussion using IRAC?

<u>Monday</u>: Students will get back In Class 4 Graded Assignment. Discussion of student outline and final discussion of putting together the closed memo.

<u>Wednesday</u>: **FIRST DRAFT OF CLOSED MEMO DUE AT START OF CLASS**. Students should bring 2 copies of their memo. One to hand in to the Professor and one to use during the self-editing exercise.

#### ASSIGNMENT OF OPEN MEMO PROBLEM

*In-Class Assignment 5*: Self-editing my legal memorandum.

<u>Required Reading</u>: Preparing for Practice Chapters 10 & 11. <u>Connected quizzes for chapters 10 & 11 will open on 2/9 and must be completed by 2/15 at 11:00PM.</u>

Week of February 17<sup>th</sup>: Introduction to legal research: Where do I go to find information about the legal implications of my client's problem? Where do I look for the most relevant and binding authority? What resources are available to help me solve my client's problem? How do I select the right authority? How do I identify the legal problem in my client's case? How do I develop a research strategy?

**Monday: WESTLAW TRAINING (Subject to change)** 

<u>Wednesday</u>: Conferences: Students meet with instructors individually to review instructors' comments on first draft of Closed Memo.

**Week of February 24<sup>th</sup>**: Further Discussion of the Open Memo problem combine with an introduction to library research. How do I begin to decide on the authorities I will use in my memo? How do I refine my plan? How do I know if I need to keep looking for authority, or if I have exhausted my research efforts?

**Monday: FINAL DRAFT OF CLOSED MEMO DUE AT START OF CLASS. LEXIS TRAINING (Subject to change)** 

<u>Wednesday</u>: Discussion of Open Memo Problem & Library Tour. *In-Class Assignment 6*: Draft the Issue for the Open Memo.

Week of March 3rd: Further Discussion of Open Memo Problem.

Monday: Discussion of Open Memo Problem and results of student research.

Wednesday: In Class 7: Citation Exercise.

Week of March 10<sup>th</sup>: Students must be prepared to present at least three cases a day to the class for the next two weeks of classes; students should have written briefs prepared for all these cases.

Monday: Case Presentations. Wednesday: Case Presentations.

**Required Reading:** Cases students have found through individual research.

# Week of March 17th: NO SCHOOL SPRING BREAK

Week of March 24<sup>th</sup>: Students will continue to present the cases they have found for their open memo. Students will be questioned on critical aspects of the cases, so the class can determine whether the authority is useful to their client's problem.

Monday: Case Presentations.

In Class 8: Draft Headings and Point Heading for Open Memo.

Wednesday: Wrap up discussion of open memo and answer any final student questions.

Required Reading: Preparing for Practice Chapters 12 & 13.

Connected quizzes for chapters 12 & 13 will open on 3/23 and must be completed by 3/29 at 11:00PM.

Week of March 31<sup>st</sup>: This week students will learn how to communicate with a different audience; the client. We will also begin transitioning to trial advocacy involving yet another audience; the court.

### **Monday: FIRST DRAFT OF OPEN MEMO DUE AT START OF CLASS.**

Now that I've predicted the likelihood of success of my client's case, how do I inform the client of my findings? What information should I include in a client letter? What information should I omit from a client letter? How and when do I communicate with clients electronically? What are the advantages and disadvantages of electronic communication? What is proper e-mail etiquette?

Review materials on client letters. Students will generally have time, in class, to begin drafting the client letter.

Wednesday: Client Letter Due at Start of Class.

**Introduction to the Trial Memo.** 

Discuss drafting trial memoranda along with format including use of forms for format.

Week of April 7<sup>th</sup>: Preparing to transition to documents drafted for courts rather than inter-office memoranda. Editing and refining legal analysis. Discussion of trial memo along with research and discussion of authorities.

Monday: Review of graded draft of Open Memo with instructors.

Wednesday: FINAL DRAFT OF OPEN MEMO DUE AT START OF CLASS.

Discussion of Trial Memo, Library Tour/Research

*In-Class Assignment 9*: Draft the issue for the trial court memo.

**Required Reading:** Materials on drafting documents to trial courts.

Week of April 14<sup>th</sup>: By this week students should have authority that supports the grounds for their motion. Students should come to class with briefs of the cases they plan to use in the trial memo.

Oral Advocacy: How do I take the information in my predictive memo and present the authorities to persuade a judge to rule in my client's favor? What is a motion? How do I refine my arguments to focus on the specific issue before the trial court? How do I take the information in my predictive memo and begin to rank and analyze the authority to persuade a judge to hold in favor of my client?

Monday: Discussion of Trial memo motion including cases students have found.

<u>Wednesday:</u> Preparation for trial court arguments: Overview of and discussion of oral advocacy. Group will watch MCLE Judge's Videos.

Week of April 21st: Students will continue to refine their trial memos and will begin formal oral argument practice.

Monday: NO SCHOOL PATRIOTS DAY

<u>Wednesday</u>: Oral Argument Practice. In Class 10: Oral Argument Practice

Week of April 28th: Oral Advocacy practice

<u>Monday</u>: **Trial Memo Due at the start of class.** Final oral argument practice session.

Wednesday: Mock Motion Session

Students will come dressed for court and argue their motion in front of a mock trial court.

Monday, May 5th: Last Day of Classes.
