## **SUMMER SCHOOL SCHEDULE - 2025**

Registration for the first summer session will be Tuesday, **May 7, 2025** from 8 a.m. to 6 p.m. Registration for the second summer session will be Tuesday, **June 11, 2025** from 8 a.m. to 6 p.m.

## STUDENTS PRESENTLY ON ACADEMIC PROBATION MAY NOT ATTEND SUMMER SCHOOL CLASSES.

In order to participate in the Clinic, you must have successfully completed Evidence and receive approval from Dean Sullivan.

A minimum of eight (8) people must register for a class in order for it to be offered.

If you have completed only one semester and you have completed *Contracts*, you may take only *UCC*, *Part I and Negotiating and Drafting Contracts & Agreements* in the first session, and *UCC*, *Part 2* in the second session.

If you are taking only one UCC course this summer, you will need to either take the other UCC course next summer or during the Fall semester. Both sections are necessary to complete your graduation requirements.

Your Faculty Advisor must approve and sign your course schedule (or send an email to the Registrar that your schedule is approved) before you register. Registration forms may be picked up from the Registrar's office and will also be available online. You may take two courses per session if you are not working full time during the summer. Courses may be dropped without academic penalty during the first week of a summer session.

Full payment is due at the time of registration, unless you are taking a class that extends over the whole summer. Tuition payment methods are by check, cash, Zelle payments (<u>Bowab@MSLAW.edu</u>), Venmo payments (@MassLawSchool), or PayPal (payments@mslaw.edu). There are no federal loans for summer school tuition. No refunds are given once the class you are enrolled in has met.

There is a \$50.00 late fee for registering after May 7 and/or June 11. There is \$100.00 late fee for registering once classes have begun.

Any student who wishes to sign up for a limited enrollment class, it will be on a first-come, first serve basis on the day of registration.

ANY STUDENT WISHING TO TAKE COURSES AT EITHER NICHOLS, FISHER COLLEGE OR FITCHBURG STATE UNIVERSITY MUST REGISTER WITH MSL FIRST. NO CREDIT WILL BE GIVEN FOR COURSES TAKEN AT EITHER OF THESE THREE INSTITUTIONS IF THE STUDENT HAS NOT REGISTERED WITH MSL FIRST. PAYMENT IS TO BE MADE DIRECTLY TO NICHOLS, FISHER OR FITCHBURG, NOT TO MSL.
